

## **2026 Huayu Enrichment Scholarship Frequently Asked Questions (For Malaysian Application)**

**Q:** Can I submit application documents via email?

**A:** No, the applications must be done via the Scholarship Online Application System (<https://taiwanscholarship.moe.gov.tw/Apply>).

Applicants must print out the application form after completing the application online, and send all the hardcopy documents to TECO in Malaysia.

**Q:** Does the Huayu Enrichment Scholarship cover the tuition fees of a language program?

**A:** The awardees will be provided a fixed monthly stipend of TWD 28,000 during the award period. The stipend can be used to cover the cost of tuition.

**Q:** How long is the award term of the Huayu scholarship?

**A:** Applicants can apply for a two-month summer course (either June–July or July–August 2026), or for courses lasting 3 or 6 months. Applicants should indicate your preferred scholarship duration in your application and submit an admission letter that corresponds to that term. However, the final duration of the scholarship will be determined by the Scholarship Committee and may be shorter than the duration applied for (for example, an applicant may apply for a six-month course but be awarded only three months of scholarship).

**Q:** Can I apply for a Chinese language course for 6 months or more?

**A:** Yes. You may indicate your intended study duration (terms) in the application documents and attach proof of your application or admission to the Chinese language course. If your actual study period goes beyond the scholarship duration, you can continue your studies at your own expense for the extra time.

**Q:** Shall I apply for admission to the language center myself?

**A:** Yes, the application processes for scholarships and language center admission are separate. Scholarship applicants must apply directly to the language center before

applying for the scholarship. Proof of admission to the language center is required when applying for the scholarship.

**Q:** Which language center can I apply to for admission?

**A:** HES applicants should apply for admission at Mandarin language centers affiliated with universities approved by the Ministry of Education. The eligible language center list can be found on the website: [lmit.edu.tw/lc/school\\_list](http://lmit.edu.tw/lc/school_list)

**Q:** Do I need a TOCFL certificate for applications to HES?

**A:** No. The TOCFL certificate is not required for HES application.

**Q:** When should I submit the admission letter?

**A: Applicants need to submit a copy of the admission letter to TECO no later than June 30th, 2026.**

**Q:** As a recipient of HES, when will I receive the scholarship?

**A:** In general, the Mandarin Language Center where you're studying will initiate the scholarship payment reimbursement process with the Ministry of Education (MOE) after you've completed your registration on campus. It's advisable to prepare at least two months' worth of living expenses, as the reimbursement process can take some time.
